6. Finances:

Clerk explained the accounts for the year end March 2020 and the new financial year for April 2020. Internal Auditor has the accounts at present. Burnham Norton for the hire of Clerk was less because the direct debit had not been changed in time. A cheque will be raised for the shortfall in this direct debit. All approved. Proposed by Cllr S Raven, seconded by Cllr K William-Powlett

- 7. CIL form: CIL form for the Borough Council approved. Goal Posts exc of VAT £489.80 and installation of goal posts £150. Balance of CIL £1718.20. Approved. Proposed Cllr K William-Powlett seconded Cllr S Stevens
- 8. Insurance BHIB: Insurance was under a three-year contract with BHIB. The invoice was for £359.07. Approved. Proposed Cllr A Edwards Seconded Cllr S Raven
- 9. Standing Orders/Direct Debits: Three at present. Currys laptop insurance £5.50 a month, ICO £35 a year and the Open Spaces £45. Approved. Proposed Cllr S Raven seconded Cllr K William-Powlett.
- 10. Extending the delegation of Council decisions to the Clerk during any period of restricted activity declared by the Government in respect of the Covid-19 virus. Such delegation is intended to enable the council to fulfil its responsibilities to its residents: Clerk explained the reason behind the delegation of the Council to the Clerk in emergencies only. Clerk to use this in emergency but with notification at the earliest opportunity the Chair and Vice-Chair in accordance with the Standing Orders. Proposed Cllr K William-Powlett Seconder Cllr A Edwards
- 11. Clerks General Power of Competence: Unfortunately, this could not be used. 5 Councillors had to be elected and there were only four at present with two co-opted and one seat remained empty.
- 12. Co-Option of resignation of Councillor: Henrietta Faire had resigned after a considerable number of years on the Council. The Borough Council had been informed and Notice for Election had been placed on the website and noticeboards. A period of fourteen days was up on Tuesday 12th May and the Borough Council would notify if an election were due to take place. If not, the Parish Council were free to co-opt. Agreed to wait until the Parish Council can advertise better.

13. Planning:

- a) Proposed garage/boat store and annexe at The Granary East Harbour Way Burnham Overy Staithe Norfolk PE31 8JF Ref: 20/00562/F Cllr K William-Powlett declared an interest as neighbour. Only observation with the following condition: Should not be used as a separate residence only as ancillary to the main dwelling. Proposed Cllr A Edwards seconded Cllr S Raven
- b) Decision submitted to the Borough Council for: Ref: 20/00462/F Trafalgar House, East Harbour Way, Burnham Overy Staithe No observations were sent to the Borough.

14. To approve: -

- a) Standing Orders for large Council Approved, Signed by Chair, Cllr S Raven
- b) Financial Regulations Approved, Signed by Chair, Cllr S Raven
- c) Social Media Policy Need to be revised. Discussion regarding social media and personal opinions.
- 15. 77 Acres: Advisory Group had meet with Holkham. From this meeting queries were raised, and the Advisory Group had written for advice from NP Law on matters. Unfortunately, things had been held up due to hours used up with NP Law and had to wait until the new subscription and because of Covid-19. Agreed that if Henrietta Faire still wanted to be an active member on the advisory group she could. All agreed.
- 16. Reports from meetings attended by Councillors: Cllr A Edwards had been on planning training by Zoom but unfortunately there were technical issues. Clerk had attending Networking for Clerks every two weeks for up to date information.

- Norfolk County Council update for the decision by the Planning Inspectorate.
- Historic England been in touch regarding the posts around the Brothercross

- Rangers Noticeboard to be strimmed. Weed control along East Harbour Way and Chapel Lane, Drain on New Road which is blocked. Bench to strim around bench at New Road. Strim round BT Phone Box. Hedge hanging out on Mill Road/New Road. Clerk to report to Holkham. Boathouse had strimmed all the verges on East Harbour Way and looked nice and tidy. Fantastic job. Clerk to contact BT to investigate how to make a call as no pay or card slots. This could only be used if a reverse charge was made.
- 18. Items for next agenda: None. Discussion on playground to remain closed as per the government guidelines. Table Tennis Table cannot be reopened as this is part of the play equipment and not separate.

 - Cllr A Jamieson The Coronavirus is causing a great deal of cost to Norfolk. Lot of changes at Norfolk County Council. NCC would like to be carbon neutral. The AONB are helping. Eight recycling centres opened today and another 8 will be opening soon. Emerging slowly from lockdown. If there are any issues in relation to the Coastal Path the Norfolk Trails team can help with Notices. Social distances must be enforced. Information can be issued to remind people to social distance 2 metres. Brancaster car park opening on Wednesday but not sure about Holkham.
