## **Ongoing from Previous Minutes: -**

#### Trees

Waiting for Lease to be completed.

## Dog Bin on Hard

No objections received from property owners, SHADCRA confirmed permission. Dog bin ordered and received. Waiting for quote to install dog bin on fence.

#### **Local Plan**

The consultation has opened, and the wording agreed at the meeting has been sent to the Borough Council. An acknowledge has been received to say this has been added to the consultation.

#### CGM

Ongoing issues with invoices. Still chasing to rectify.

### **Highways**

Yellow lines and bus stops will be repainted as soon as the weather allows. The resurfacing of the A149 through parish will commence next year.

## **Playing Field**

Skate Ramp has been repaired. Blue Rocker/springy has been removed.

## Trains and Bus Linking timetable

Update from James Wild MP. A meeting has now taken place between Thameslink and Great Northern Railways, and Lynx. The timetable for the bus and trains have been timed so they fit in with the available train paths and other bus connections in the area and therefore it is difficult to change the times without causing another problem somewhere else. The main problem is for passengers travelling beyond Hunstanton to the coast. This service is only used by a very few people in the winter and in the summer months (April - September) it is generally busier on a Thursday to Friday when people are travelling up for weekends on the coast. The parties agreed to meet again in March next year to review the situation and whether passenger numbers have increased to make an additional service or alternative arrangements possible.

## **Updates for Meeting**

#### Item 7 – Queens Platinum Jubilee

The Hero would like to position their own bench. Discussion will be needed for another place for the Jubilee bench to be positioned or another idea for the Jubilee.

#### Item 8 - Welcome Back Fund

Spoken with Borough Council regarding Welcome Back Fund. Ideas and opinions for the parish can be sent to the Borough Council in which they might consider making to the parish by way of a project. Discussion on new dog bins for Hard.

## Item 9 – Tree Plaque size and Position for Millennium Oak Tree

Wording has been suggested and agreed. Councillors need to agree size and placement for plaque.

## Item 10 – Strimming under dog bins quote

Quote given by CGM to add strimming under the dog bins on the Hard. £10 plus VAT per visit. Suggestion to have completed at the same time for the grass maintenance once a month from April to October.

#### Item 11 – Grit bin

Grit bin has been damaged on Gong Lane. This was reported to the Police. Councillors to discuss whether to claim on insurance or purchase a new bin. Excess of insurance would be £125 on insurance.

#### Item 12 – Allotments Black Matting

The 1/3 allotment has been taken, this leaves two  $\frac{1}{2}$  plots and a full plot. I have people interested in the full plot at present. Black matting quote was for two  $\frac{1}{2}$  plots and a 1/3 plot so would be cheaper. No alternative quote.

### Item 13 – Laptop

Laptop is now five years old. It is covered by insurance for breakdown. A repair is being undertaken at present as the screen keeps blanking out. As budget is being completed to discuss the purchase of a new laptop.

## Item 14 - Budget

Budget is only first draft and needs to be agreed by the meeting in December. Councillors need to consider notes on the reserve sheet. The new tax band has not been sent until December.

## **Item 15 – Co-Option**
